DIRECTIONS

1. Remove loose or excess residue.
2. Apply Gum Gel Adhesive Remover full strength to the adhesive. Avoid over-application.
3. Agitate Gum Gel Adhesive Remover into area with any hand held implements like a bone scraper. Poke into the contaminant surface to allow the Gum Gel to penetrate.
4. Allow to dwell for 3-5 minutes.
5. Blot or scrape up excess Gum Gel Adhesive Remover along with any adhesive that has been loosened. Repeat steps 2-5 if necessary.
6. Blot and rinse the area thoroughly, using extraction equipment and clean water, then brush fabric to align fibers.
